## Submission

Manuscripts must be submitted electronically on disk or via email to the following address: [Religion&Theology@unisa.ac.za](mailto:Religion&Theology@unisa.ac.za). Manuscripts must be submitted in MS Word format, but an ASCII file of the document should also be provided. The disk must be clearly marked with the name of the author, the title of the article and the file name. All 'special effects' in the text such as bold, italics, and watermarks should have been removed. Use italics only where required by convention, for example, for the titles of books.

The manuscript must be an original contribution, which has not been published previously, written in English, French or German. Authors must include a covering statement declaring that the manuscript is their own work and that all copyright permissions, etc. have been obtained. An abstract must also be provided at the beginning of the article. Photographs can be submitted as electronic files, slides or glossy prints. When supplied as electronic files, line drawings should have a *minimum* resolution of 600 d.p.i. [dots per inch]. Photographs should have a minimum resolution of 300 d.p.i. The file format should be .TIF(F), .JPG or .EPS; a printout should always be supplied. Coptic, Greek, or unvocalised Hebrew may be used in the text provided that fonts obtainable in the public domain (such as from Perseus/Silver Mountain or SBL) are used; if transliterated, and in the case of other foreign languages, these must be transliterated according to the guidelines provided in *The SBL Handbook of Style: For Ancient Near Eastern, Biblical, and Early Christian Studies* (Peabody, Mass.: Hendrickson, 1999) or in consultation with the relevant standard grammars and dictionaries.



### Style

The manuscript should include an abstract of not more than 100 words and 2-6 keywords.

Please number headings, but do not use more than two levels of headings.

Use footnotes.

For references in the text, follow the style as set out in *The SBL Handbook of Style*. Please avoid the use of *ibid.* or *op. cit.*; give full bibliographic details in the first occurrence of a reference, thereafter use short titles.

References to biblical documents, other classical authors and reference works must be made according to the style as set out in *The SBL Handbook of Style* or the other reference indexes listed in the *SBL Handbook*.

### Proofs

In order to avoid long delays in returning proofs, authors do not receive proofs from the copy-editor. The editorial committee reserves the right to exercise its discretion with regard to copy-editing.

Authors each receive three free copies of the issue in which their articles appeared.

### Consent to publish

#### *Transfer of copyright*

By submitting a manuscript, the author agrees that the copyright for the article is transferred to the publisher if and when the article is accepted for publication. For that purpose the author needs to sign the **Consent to Publish** which will be sent with the first proofs of the manuscript.

#### *Open Access*

In case the author wishes to publish the article in **Open Access** he/she can choose the **Brill Open** option, which allows for a non-exclusive Open Access publication in exchange for an Article Publishing Fee, and sign a special **Brill Open Consent to Publish**.
